- 1. Project Background: FMC is implementing a project: NHPC Ltd in consultation with IRMA, through network partner Foundation for MSME Clusters (FMC) is implementing a livelihood initiative for women weavers of Assam in Dhemaji and North Lakhimpur Districts for promotion of handloom clusters of women weavers, enhancing income opportunities for weavers through new design/product creation and linking them with contemporary buyers and the market. Under this intervention, a Producer Company "SAAR Handloom" of 200 women weavers which is likely to increase by another 200-300 in the next 2 years to make it a 500 women weavers Producer Company.

### 3. Scope of work
